### >> IRA ROLLOVER

If you are 70½ or older, an IRA charitable rollover will help continue our work and benefit you this year. Contact your IRA plan administrator for more information and to make a gift from your IRA to the CMH Foundation.

### >> BENEFICIARY DESIGNATION GIFTS

Designate the Foundation as a beneficiary of a retirement, investment or bank account, or your life insurance policy.

To make your gift, contact the person who helps with your account or insurance policy, such as your broker, banker or insurance agent.

### >> CHARITABLE GIFT ANNUITY

The charitable gift annuity program is a strategic donation method. In return for your gift to the Foundation, you receive a fixed income stream for the rest of your life or that of a designated beneficiary. In addition to your income, you could be eligible for tax breaks.

### >> CHARITABLE REMAINDER TRUST

You choose to receive an income first from distributing the non-income-producing assets you placed into the trust. You'll receive a charitable donation tax deduction based on the present value of the remainder of the assets earmarked for the charity.
